AND WHEREAS the Broker has agreed with the client to provide such online Trading facility upon the terms and the conditions hereinafter mentioned and the client has agreed with the Broker to act in compliance with the said terms and conditions hereinafter mentioned and to enter into and execute these presents.

RESPONSIBILITES AND OBLIGATION OF EACH PARTY

CLIENT

1. The on line application system/systems shall be used solely for the purpose of operating the CDS account of the client and shall not be used by the client to operate CDS accounts of any other person, except in instances set out in the guidelines issued by the CSE.
2. The client is responsible & liable for the settlement of all trades executed through the User ID & Password provided by the broker.
3. The client is responsible & liable for all trades including any unauthorized/manipulated trades via online trading system provided by the broker.

BROKER

1. Broker shall provide a link to client to enable them to access the CSE/CDS/SEC Rules
2. Broker Ensures the confidentiality of information provided by the client & shall not be disclosed to any other person except in instances set out in the guidelines issued by the CSE.
3. The broker shall have the sole discretion of changing the software vendor and any /modifications/restrictions to the online trading system.

BROKER AND THE CLIENT

1. All trades shall be subject to Rules & Regulations of the CSE & CDS.
2. This agreement shall be governed by and be subject to the applicable laws for the time being in force in the Democratic Socialist Republic of Sri Lanka
